Dear Prime Minister,

As organisations representing the health professions, patients, NHS staff and NHS organisations, we are dismayed at the continuing delay in publishing a funded health workforce plan for England. We urge you to act by publishing a sustainable plan immediately. None of your policy commitments on health can be achieved unless we address the chronic workforce shortage.

Across all sectors, professions, specialities, condition pathways and services there are mass vacancies and insufficient numbers of staff to meet current, let alone future, population need. It will take time to resolve this situation, which is why the delay in acting to address the workforce crisis is so damaging. The sooner we start to train and recruit more staff, and act to retain those already serving the public, the sooner we will see improvements in healthcare.

Many of us have contributed to developing the workforce plan. We want it to succeed. We want to be able to welcome it if it provides the long term vision needed and clearly commitments to funded workforce expansion. Please act now.
